Resolution to Amend the Board of Directors Rules of Procedure

The following shall be added as Rule XIV of the University at Buffalo Student Association Inc. (“SA”) Board of Directors Rules of Procedure:

RULE XIV: Effect of Violation

Section 14.01. Effect of Violation:

- a. Notwithstanding any other provision, no violation of these Rules of Procedure or Robert’s Rules of Order shall result in the invalidation of any otherwise valid action of the SA Board of Directors or any Board Committee.

Resolution to Waive Club Requirements

The following requirements shall be waived for all University at Buffalo Student Association Inc. (“SA”) clubs for the University at Buffalo 2020-2021 academic year: meetings per semester, events per semester, SA event participations per semester, community service events per semester, and fundraising requirements. This Resolution shall supersede any SA clubs policy for the University at Buffalo 2020-2021 academic year.


