## **Executive Committee Resolution - 2023-2024 - #2**

### **Subject: Resolution to Repeal Printing Policy**

WHEREAS, University at Buffalo Student Association Inc. (“SA”) is committed to the concept of sustainability, renewable energy, and otherwise taking action to slow, stop, and reverse global climate change, and therefore desires undertake measures to limit the negative impact it has on the climate; and

WHEREAS, for the above stated reasons, the Student Association desires to reduce paper use by the clubs; and

WHEREAS, clubs have numerous avenues available to them to market their events for free using digital means; and

WHEREAS, this Resolution will save SA money, both in the reduction of supplies purchased and staff time necessary to do the work of printing; and

WHEREAS, this Resolution shall not prohibit clubs from purchasing printing from third party vendors, so long as any such purchase complies with applicable SA policies; and

WHEREAS, this Resolution shall apply to all SA clubs;

NOW THEREFORE, BE IT RESOLVED, that effective immediately, SA shall no longer print materials requested by clubs (including but not limited to flyers, handouts, posters and banners); and

BE IT RESOLVED, that effective immediately, SA’s Printing Policy is hereby repealed.
