Resolution - 2024-2025 - E#8

Subject: Resolution to Temporarily Modify Annual Registration and Requirements for Recognition Policy

Submitted by: Samin Bhuya, SA President; Killian Hannigan, SA Vice President; Louis Poon, SA Treasurer.

WHEREAS, University at Buffalo Student Association Inc. (“SA”) seeks, in the interest of justice, to allow the maximum amount of SA clubs to remain recognized; and

WHEREAS, given the potential loss of opportunity to SA and its clubs due to any delay, the SA Executive Committee intends to act to allow the maximum amount of SA clubs to remain recognized; now, therefore,

BE IT RESOLVED that the SA Annual Registration and Requirements for Recognition Policy is temporarily modified, for 2024 only, to extend both Deadline 5 and Deadline 7 until December 2, 2024, for all clubs; and

BE IT RESOLVED that this Resolution shall take effect immediately.
