**Subject:** Resolution to Amend the SA By-Laws to Add Two Additional Vice Presidents Beginning in the 2025-2026 Term to Expand Democratic Opportunities for UB Undergraduates

**Submitted by:** Samin Bhuya, SA President; Killian Hannigan, SA Vice President; Louis Poon, SA Treasurer.

**WHEREAS**, it is in the best interests of UB undergraduate students to have additional opportunities to run for student officer positions;

**WHEREAS**, it is in the best interests of UB undergraduate students to have additional opportunities to vote on important positions;

**WHEREAS**, bringing more elected student representatives' voices into important conversations on a daily basis allows for greater representation of the student body as a whole;

**WHEREAS**, having each Vice President focus on specific areas (clubs, advocacy, and events) allows students to run for and hold positions that more closely align with their individual interests and skill sets;

**WHEREAS**, the 3 pillars of University at Buffalo Student Association Inc. ("SA") are clubs, events and advocacy, and permitting individual SA Officers to focus more directly will allow for greater focus on each pillar; and

**WHEREAS**, the new elected position of Vice President for Advocacy is intended to replace the appointed position of Student Affairs Director, starting with the 2025-2026 term; now, therefore,

**BE IT RESOLVED** the following positions shall be elected in the SA 2025 spring semester officer elections, for the 2025-2026 term: President, Vice President for Clubs, Vice President for Advocacy, Vice President for Events, and Treasurer;

**BE IT RESOLVED** that, effective 12:01 a.m. on May 16, 2025, the SA By-Laws shall be amended as follows:

1. The text of Section 5.02(b) shall be replaced as follows:

The Vice President for Clubs:

- (i) Shall be a voting member of the Senate and Executive Committee.
- (ii) Shall assist Student Association recognized clubs in the performance of their operations.
- (iii) Shall assist the President in coordinating the student staff in SA's club services department, including holding regular department meetings.
- (iv) Shall assist and advise any students desiring to establish a new SA club.
- (v) Shall make known to all recognized SA clubs the resources and services offered to them by the Student Association.
- (vi) May sanction clubs which violate any applicable law or policy to the extent provided for in any duly adopted SA policy.
- (vii) Shall have the power to grant recognition to new clubs, and to derecognize clubs, with the approval of the SA President or Treasurer, to the extent provided for in any duly adopted SA policy.

2. The following shall be added as Section 5.02(c):

The Vice President for Advocacy:

- (i) Shall be a voting member of the Senate and Executive Committee.
- (ii) Shall discharge the duties of the President as Acting President upon written authorization from the President; the President may revoke such authorization at any time upon notice to the Vice President for Advocacy.
- (iii) Shall assist the President in coordinating the student staff in SA's student affairs department, including holding regular department meetings; and to the extent requested by the President, shall assist the President in otherwise coordinating the operations of the Executive Branch.
- (iv) Shall represent the President on occasions designated by the President.
- (v) Shall act as an advocate for students in the areas of student rights and student welfare.
- (vi) Shall serve as a channel of communication between SA and the University administration.
- (vii) Shall work to foster student representation and student input in university policy-making.
- (viii) Shall deliver report(s) to the Senate on issues of importance to the student body, and if requested by the Senate, present advocacy resolutions passed by the Senate to the University at Buffalo.

3. The following shall be added as Section 5.02(d):

The Vice President for Events:

- (i) Shall be a voting member of the Senate and Executive Committee.
- (ii) Shall work on SA events, activities, and programming.



- (iii) Shall assist the President in coordinating the student staff in SA's entertainment and programming departments, including holding regular department meetings.
- (iv) Shall research potential events, activities, and programming.
- (v) Shall seek student input and coordinate polling about potential events, activities, and programming, except as relates to clubs.
- (vi) Shall work with relevant staff to coordinate a schedule of events for the academic year.
- (vii) Shall work on proposals for events, activities, and programming.
- (viii) Shall offer recommendations for improving existing events, activities, and programming, within what is reasonably possible.

4. Section 4.01(a)(i)(9)-(11) (as currently numbered) shall be replaced as follows:

- 9) The Vice President for Clubs
- 10) The Vice President for Advocacy
- 11) The Vice President for Events
- 12) The Treasurer

5. The text of Section 4.02(c)(i) shall be replaced as follows:

Membership

The membership of the Executive Committee shall consist of the following:

- 1) The President (who shall be the Chairperson of the Executive Committee)
- 2) The Vice President for Clubs
- 3) The Vice President for Advocacy
- 4) The Vice President for Events
- 5) The Treasurer
- 6) The Chairperson of the Senate

6. The text of Section 4.02(c)(ii) shall be replaced as follows:

Quorum

A quorum for any meeting of the Executive Committee during the UB Fall or Spring semester shall be ~~three (3)~~ four (4) members, except that if any position(s) comprising the membership of the Executive Committee is unoccupied, quorum shall be ~~two (2)~~ three (3) members of the committee. During all other times of the year, quorum of the Executive Committee shall be ~~two (2)~~ three (3) members of the committee.

7. The text of Section 5.02(e)(i) (as currently numbered) shall be replaced as follows:

A contract may be executed on behalf of the Student Association, or an expenditure may be approved by the Student Association, only if such contract or expenditure is approved by the Student Association Treasurer (or designee appointed by the Treasurer in writing) and either the Student Association President or any Vice President designated in writing by the President. Any expenditure for \$50,000 (United States Dollars) or more for any entertainer or performing artist (except for a club event) shall require the approval of the President, the Vice President for Events (unless the position is vacant or that person is suspended), and the Treasurer.

8. In Section 5.02(e)(ii) (as currently numbered), the text “either the Student Association President or Vice President” shall be replaced by “President”;
9. Section 5.02(c) (as currently numbered) shall be renumbered 5.02(e), Section 5.02(d) (as currently numbered) shall be renumbered 5.02(f), Section 5.02(e) (as currently numbered) shall be renumbered 5.02(g), references to “Section 5.02(d)” that appear in Section 5.03(c) (as currently numbered) shall be replaced with “Section 5.02(f)”, and references to “Section 5.02(e)(iii)” that appear in Section 10.01(i)(i) (as currently numbered) shall be replaced with “Section 5.02(g)(iii)”;
10. **BE IT RESOLVED** that, effective 12:01 a.m. on May 16, 2025, all references to “Vice President” in each of the following SA policies shall be changed to “Vice President for Clubs”: Club Constitution Policy, New Club Recognition Policy, Club Violations Policy, Alcohol Policy, and Fraud and Irregularities Awareness and Reporting Policy;

**BE IT RESOLVED** that, effective 12:01 a.m. on May 16, 2025, all references to “either the SA President or Vice President”, and “either the President or Vice President”, in each of the following SA policies shall be changed to “President”: Capital Equipment and Disposal Policy, Fundraising, Revenue, and Rollover Policy, and Inventory Policy;

**BE IT RESOLVED** that, effective 12:01 a.m. on May 16, 2025, the reference in the SA Encumbrance and Expenditure Policy to “Either the SA President or Vice President” shall be changed to “Either the Student Association President or any Vice President designated in writing by the President”, and the words “The President or Vice President are” shall be changed to “The President or designated Vice President are”;

**BE IT RESOLVED** that, effective 12:01 a.m. on May 16, 2025, the reference in Section 4(b) of the SA Election Rules to “5.02(e)(iii)” shall be changed to “5.02(g)(iii)”;

**BE IT RESOLVED** that, effective 12:01 a.m. on May 16, 2025, the SA Encumbrance and Expenditure Policy be amended, adding an additional section titled “Required Additional Approval for Certain Entertainer and Performing Artist Expenditures” after the section titled “Trade Agreements and In-kind Agreements”, containing the following text:

Any expenditure for \$50,000 (United States Dollars) or more for any entertainer or performing artist (except for a club event) shall require the approval of the President, the Vice President for Events (unless the position is vacant or that person is suspended), and the Treasurer.

**BE IT RESOLVED** that underlining used throughout this Resolution is for convenience of reference here only, and such text shall not be underlined in the amended SA By-Laws or policies; text struck through throughout this document is for convenience of reference only, and text shown struck though in this document shall not appear in the amended SA By-Laws or policies; quotation marks in this Resolution shall not appear in the amended SA By-Laws or policies; and, to the extent necessary, the page numbers and section names included in the By-Laws’ table of contents shall be adjusted as necessary to reflect the changes set forth in this Resolution.
